

Vascular Society - Presidential Update

Vascular Society Council met as it traditionally does in the second week in September. Normally this would be held in London, but with the current COVID 19 crisis, this was another virtual meeting. Our last face to face meeting was pre-CV19 in Cardiff.

Restoration of services

This was a major topic for discussion within VS Council. Many of the difficult implications for patients and staff were discussed. As I have alluded to in previous newsletters, whilst closing down services was extremely challenging, trying to reopen them is proving to be even more so. The Vascular Society recently undertook two surveys of the membership to try and understand what the particular blockages there are to re-opening.

Elective operating capacity

GIRFT, and the CRG on the topic.

A recurring message is that currently there is only a limited restoration of elective vascular lists. The most recent survey, undertaken at the beginning of September, showed that only 32% of units have a full restoration of elective lists. The September survey did however show there were now no vascular units operating solely through NCPOD lists. However, there remains a marked reduction in capacity to deal with elective workload, and in particular patients awaiting elective abdominal aortic aneurysm surgery have been affected. There have been ongoing discussions with the devolved nation NAAASP surgical directors,

The vascular team

Vascular patients require an integrated multidisciplinary team (including nurses, interventional radiologists, vascular technologists, vascular anaesthetists, and surgeons) to deliver optimal care to vascular patients. Restoration of the vascular teams remains an important component to the restoration of services.

Trainees

The VS believe it is crucial that vascular trainees need to remain working within vascular surgery, if at all possible, in order to continue their training. The FY1 and FY2 surgical staff are also required to support both the elective and urgent surgical patients. Should the CV19 crisis deteriorate significantly again, it may be necessary to redeploy staff but the implications on patient care, safety and throughput need to be understood by medical leaders, if staffing levels need to be significantly reduced again.

GIRFT, the CRG and NHS England

The Vascular Society have been in close and regular discussions with the CRG and Vascular GIRFT. A further joint document, with Vascular GIRFT, on restoration of vascular surgery is due to be published very shortly. NHS England have thanked the Vascular Society for its ongoing collaboration with the CRG and Vascular GIRFT in helping plan the restoration of services. I would like to thank everyone who has contributed to the anonymous surveys that have been a crucial part of the planning process.

Circulation Foundation
