Full member
- €172*

For vascular surgeons.

Trainee member (EVST) - €65

For vascular surgeons *in training*. Any individual having completed their training must be registered as a "Full member".

Senior or retiree member - €65

For retirees, or individuals over 65 y.o. and who have been members for at least 5 years.

Printed EJVES supplement - €45*

MEMORANDUM OF UNDERSTANDING 2024

BETWEEN ESVS AND VASCULAR SOCIETY OF GREAT BRITAIN AND IRELAND

1. Parties

This Memorandum of Understanding (hereinafter referred to as "MOU") is made and entered into by and between the ESVS and VSGBI.

2. Purpose

The purpose of this MOU is to establish the terms and conditions under which the ESVS-VSGBI membership agreement will function.

3. Term of MOU

This MOU is effective upon the day and date signed below. The term of the MOU mirrors the ESVS membership term.

4. Responsibilities of ESVS

The ESVS will:

- Provide personalised weblinks for the VSGBI members to purchase their ESVS memberships directly on the ESVS website.
- Provide membership support to the VSGBI members via email or telephone.
- Treat members' personal data in accordance with the ESVS Privacy Policy.

5. Responsibilities of VSGBI

The VSGBI will:

- Provide a secured webpage on which to advertise the ESVS-VSGBI agreement to its members. The webpage must only be accessible by VSGBI members who hold an active membership for the calendar year in question.
- Encourage a minimum of 10 Full member subscriptions per year
- Promote the ESVS Annual Meeting and other ESVS events on the VSGBI website and through other communication means if possible.
- Comply with the European GDPR when sharing member data.

6. General Provisions

A. Amendments. Either party may request changes to this MOU. Any amendments shall be incorporated in writing, and effective when executed and signed by all parties.


B. Entirety of Agreement. This MOU represents the entire and integrated agreement between the parties and supersedes all prior negotiations, representations and agreements, whether written or oral.
